Booking Confirmation:

A booking confirmation will be sent to the delegate or booking contact on receipt of payment, or in the case of bank transfer, following receipt of a valid purchase order reference.

Cancellation:

Cancellation refunds will depend on how long before the course start date the cancellation is received. The following refund structure will apply:

- More than 28 days will incur a cancellation fee of £200 GBP per registration and a refund of the remaining course fees
- Between 28 days and 14 days notice will qualify for a 75% refund
- Between 14 days and 7 days notice will qualify for a 50% refund
- No refund will be given for cancellations received with less than 7 days notice
- Substitutions for registered delegates will be accepted without notice

Liability:
